President Report – April 2026

Welcome to all delegates who have given their time to be here today. For some of you this may be the first delegate meeting, for returning delegates, thank you for your continued support of BDLGA.

My report will be short as the other chairs will provide you with greater detail on the activities undertaken in their various roles and responsibilities.

I wanted to start with reaffirming the mission statement of the BDLGA which is to “foster, encourage, and promote golf for women and junior girls throughout clubs in our district”. This is our core purpose, it should and does inform what we do as an association, and it identifies the difference we want to make. Using this as our first key in our role, the committee has developed a strategic plan (that you should have all received a copy of, if not please contact the Secretary, Cathy Hindmarsh for a copy). Our plan runs for four years (2026-2030) and has identified what the committee feels the association goals and performance indicators should be moving forward.

The next step in realizing our vision, is for the creation of operational plans for each of the focus areas of this association: Pennants, Juniors, Tournaments and the newly established portfolio of Special Events. This process is about to commence, and progress will be reported at the next and subsequent delegate meetings. These plans will also be available on the website once they are finalised and approved by the committee. In a time of increasing accountability, I urge all club committees (if you have not done so already) to undertake the process of setting goals for women and junior girls at your club and developing plans to achieve these goals.

As Club Captain or committee member, you may have seen the emails from Golf Australia advertising their “Level Up” program, (this is an online child safeguarding initiative designed to help golf clubs comply with national safety standards). If your club has not already signed up, I encourage you to look at the program and sign your club up.

I want to provide a brief overview of the progress of the various subcommittees and of the activities of BDLGA as a whole. As you have already heard from Cathy, a new BDLGA website redesign project has been undertaken. Other office holders have also been busy behind the scenes to ensure that the association runs smoothly.

Finances: Our finances remain strong and we are in a good position to meet future expenditures.

Pennants: the pennants sub-committee have been working behind the scenes to ensure that the season gets off to a good start with as little disruptions as possible. I wish all the clubs competing in all the various competitions the very best of luck.

Tournaments: the tournament season has commenced with some great competition on the day.

Juniors: This year, through the hard work of Jacqui Giles and others, we have seen Junior Girls Pennants back on the calendar. Thank you to the clubs who entered teams and congratulations to all the players.

Special Events: This is new portfolio, and I thank Bronwyn for stepping up and taking on this role. I will leave it to the various Chairs to provide you with greater detail on their respective activities.

I want to finish by reiterating our mission to “foster, encourage, and promote golf for women and junior girls throughout clubs in our district”. We, as an association, do this by organising events that give women and junior girls the opportunity to experience golf in a safe and supportive environment and by working with clubs to achieve their aspirations for their women and junior girl members.

3. Expenditure for the software and website, including Website maintenance and hosting plus other programs are continuing to be the largest expenditures, with Storage will continue all year.

A new website is still being finalised with a second payment being due when certain milestones have been completed.

2) Profit and Loss March 2026 (see below)

3) Notes to the Profit and Loss Report for the Financial Period 1 July 2025- 31 March 2026 (unaudited) Below:

- a) Capitation Fees for the financial year 2025 were \$4,117 higher than the previous year which was an increase of 9%. This was due to the increase of women and girls participating in golf plus an increase in affiliation fees from 1 July 2025.
- b) Tournament income is higher due to more events being held prior to July 2026.
- c) Noosa Springs shows a significant increase in income which is offset by a commensurate expense in the execution of this event. The costs involved is expected to increase due to venue and catering costs associated with providing this event in 2026.
- d) Honorarium costs associated with the committee is also higher due to a larger membership and for the provision of a course to two committee members to help with the execution of their duties. This also reflects the commitment and reimbursement of the committee members who participate in ensuring each duty performed is compensated for their volunteering in running the BDLGA. Also please note that the inclusion of a Special Events Committee person will increase honorariums for 2026-27 year.
- e) Website expenses have a minor impact with a change from MiniWebs to another website hosting provider. Plus rebuild of Website by White Peak Digital.
- f) Storage costs at the StoreLocal Hendra will continue to have a slight increase over the next twelve months due to annual costs associated with this facility and the recent owner sale.
- g) No Club Assistance grants were paid out in the past twelve months, however an outstanding grant to Wantima Country Golf Club will be honoured in the next twelve months upon completion of their project for enhancement of golf for women and girls in their club.

Junior Chair Report – April 2026

1. Junior Girls Pennants

BDLGA has just completed its first return to junior girls' pennants since COVID. We had 7 of the 8 targeted clubs' express interest in entering a team but only 5 came to fruition. BDLGA fielded an All-Stars team to give more junior girls the opportunity to compete.

In total **over 30 junior girls** played in the pennants' competition with 10 clubs fielding players.

Kepperra won the competition with **Meadowbrook** and **RQ** being one point behind.

We have invited feedback from players and their parents. At the end of the ladies' pennant season where junior girls over 13 years can compete, we will be looking for feedback from our delegates in the form of a survey.

2. Sarh Jane Kenyon Challenge

This year SCWBD does not have the players to participate so I have asked Gold Coast District if they would like a match and it looks possible on **21 June 2026**. More information to follow.

3. Brisbane Junior Amateur Championship

We have now confirmed the venue. **Pacific Golf Club** will host a junior event on Thursday in conjunction with our 2-day event to be played on **Thursday, 9 July 2026 and Friday, 10 July 2026**.

Tournament Report – April 2026

Welcome to the 2026 golf season.

Our first event of the season, the **District Championships**, sponsored by Tony Hollands Funerals, was held at **Wynnum Golf Club** on 16 March 2026. Originally, 92 players registered from 15 different clubs. However, after some late withdrawals, 85 players teed off. The weather was perfect for golf, the course was in excellent condition, and Wynnum Golf Club proved to be outstanding hosts for the day.

The competition format was **single stroke across three divisions**, as well as **Senior** and **Senior Veterans** categories, with both Gross and Net prizes contested. In addition, our Champion of Champions event was conducted alongside the main competition, featuring 5 current club champions from BDLGA clubs. **Winning players** are acknowledged below:

Champion of Champions – Kylie Jackson, Wynnum Golf Club.

Pennants Report – April 2026

1. Pennant season

The start of the 2026 Pennant season is fast approaching and will commence next weekend after the April school holidays. The **Sunday competition** will run from **19 April 2026** for 8 weeks, and the **Friday competition** will run from **24 April 2026** for 9 weeks. Both competitions have two additional dates in June for contingency to allow for rescheduling, if required.

Friday competition:

- **31 teams** (Gold, 3 x Silver, Bronze) from **18 clubs** and **will play 474 matches**.

Sunday competition:

- **23 teams** (Gold, 2 x Silver, Bronze) from **16 clubs** and will play **383 matches**.

Since our last Delegate meeting, work has been progressing to finalise the set-up in Golf Genus. This includes uploading the player list for every team, checking GA handicaps are accurate, setting up the course for each match, compiling a cart allocation list for each course, and setting up the result sheets for every match.

Golf Genus has implemented some upgrades, however this mainly affects the administrator as there is no fundamental change to how the system functions for Pennant Team Captains.

2. Training session

- Player eligibility
- Player registration
- Walkovers and late arrivals
- Pace of play
- Host Club Match Officials
- Suspension and postponement of play
- Code of conduct
